

## Best Long-Lasting Dental Therapy Product: BioMin F

At BioMin Technologies Limited the mission was clear - to develop mineral-releasing materials for dental care products to improve the oral health of the general public. And that is exactly what BioMin has achieved with its innovative products such as BioMin F, which have recently been recognised in the Healthcare and Pharmaceutical Awards 2021.

The company was established in 2014 to commercialise the award-winning research and

development of bioactive materials conducted over the past decade at Queen Mary University London and Imperial College, London. Dubbed 'Armour for Teeth', BioMin® Toothpaste is a dental therapy that has been specifically developed for complete oral care and protection and is clinically proven to provide relief from dentine hypersensitivity and to strengthen tooth enamel.

In 2016, the company's flagship offering, BioMin® F toothpaste, was introduced commercially in UK and distribution has now been expanded to over 40 countries around the world. During this time, it has developed considerable clinical evidence to support its claims. It contains bioactive materials that uniquely slowly release calcium. phosphate and fluoride ions over an eight to 12-hour timeframe to form new acid resistant mineral that strengthens and protects tooth structure and at the same time, helps neutralise the effects of acidic fonds and drink. The toothpaste is able to mimic and enhance the natural remineralisation properties of saliva.

"No other toothpaste has been designed to do this," elaborates



Judith Beare, the company's Business Manager. "Standard fluoride toothpastes are washed away within 90 minutes of brushing due to sallivary flow, however, BioMin is designed to adhere to the tooth structure whilst brushing, delivering therapeutic benefits for up to 12 hours."

This advanced technology product has additional "smart features" dissolving faster under acidic conditions to limit the damage to tooth surfaces from sugary, acidic drinks providing wrap-around tooth protection between brushings.

"This helps protect against modern eating habits of regular grazing and snacking throughout the day where the teeth are exposed to acid challenges for extended periods."

The second product offering, BioMin® C, was introduced in late 2017 for those who wish to avoid the inclusion of fluoride in toothpaste but still require relief from sensitivity. The fluoride-free formulation works similarly adhering to the tooth surface and slowly releasing calcium and phosphate mineral ions for many hours to rapidly develop a tooth-like coating.

In 2020, after intense independent scrutiny of their safety and efficacy BioMin F, and BioMin C toothpastes obtained CE certification as medical devices validating the claims for the treatment of dentine hypersensitivity.

"The CE mark accreditation is recognised not only within Notified Body. In simple terms, it allows BioMin to make much more robust claims than other toothpastes."

Europe," says certification consultant Paul Rowden, "but has massive credibility worldwide, as other countries know how much the process involves."

Edmund Proffitt, Chief Executive Officer of the British Dental Industry Association, agrees wholeheartedly.

"Registering BioMin F as a medical device puts it in a completely different league from other toothpastes," he states. "By going through the certification process, BioMin is able to make claims that are independently scrutinised and justified by a

international recognition having achieved FDA 510K approval in the United States, as well as approval from the Australian TGA (Therapeutic Goods Administration). BioMin Ftoothpaste, marketed as BioMin Restore Plus in the USA, is the first fluoride containing bioglass toothpaste to be approved by the FDA, something which even the dental giants have failed to accomplish.

"In a nutshell, BioMin F toothpaste has high level, independent, international stamps of approval, as well as a growing body of evidence from
